<p><b>Attributable fringe benefits</b></p> <ul style="list-style-type: none"> <li>If you receive fringe benefits and you or your associates (e.g. the family trust) are shareholder-employees of the company you work for and you or your associates hold voting interests of 50% or more then you need to include the fringe benefits in your family income. <p><b>Tax exempt salary or wages</b></p> <ul style="list-style-type: none"> <li>This includes salary and wages that are exempt from income tax under specific international agreements in New Zealand. <p><b>Pensions and annuities</b></p> <ul style="list-style-type: none"> <li>This includes 50% of the amount of pension or annuity payments from life insurance policies or a superannuation fund, (excluding NZ Super).</li> </ul>	<input type="checkbox"/>	
<p><b>Other payments</b></p> <ul style="list-style-type: none"> <li>These are payments from any other person or entities that are used for the family's day-to-day living expenses. If the total amount is more than \$5,000 for the tax year, then the total amount must be included as family income.</li> </ul>	<input type="checkbox"/>	
<p><b>Income equalisation scheme deposits (excludes 'adverse event' deposits)</b></p> <ul style="list-style-type: none"> <li>This includes any deposits made by you, a company controlled by you or your trust or your trust to an agricultural, fishing or forestry business income equalisation scheme account at Inland Revenue.</li> </ul>	<input type="checkbox"/>
